Tasmanian Buckskins Inc First Foal Futurity **For foals born between August 1st 2005 & July .31st 2006**

Unborn Foal Nominations: Due 31st August 2005

Conditions of Entry:

1. Any unborn foal with Tas Buckskins Inc registered sire or dam due to be born between 1 August 2005 and 31 July 2006 may be registered in the first foal futurity.
2. All exhibits must be registered with Tas Buckskins Inc in either Buckskin / Foundation or Appendix registries at the time of judging.
3. Nominators must be current financial members of Tas Buckskins Inc.
4. One owner may nominate as many unborn foals as desired but entries cannot be transferred from one foal to another.
5. A change of ownership will not affect eligibility providing the transfer is correctly recorded with Tas Buckskins Inc and the futurity organiser is notified.
6. Entry fees will not be refunded unless the event is cancelled, in which case 10% of fees paid will be retained to cover expenses.
7. Judges venue – State Show 2006,7,8
8. The best buckskin foal Futurity Exhibit will be judged if, in the opinion of the futurity organiser, there are sufficient entries from the filly / colt / gelding class winners.
9. The best appendix / foundation registered futurity exhibit will be if, in the opinion of the futurity organiser, there are sufficient entries to warrant from the filly / colt / gelding class winners.
10. Entry Fees will be held in Trust less 25% to go towards advertising & admin. Prize money will be calculated as per remaining amounts & awarded to sixth place. Trophies will be to third
11. Nomination Fees must be paid by the following dates:
UNBORN FOAL NOMINATIONS (1st Nomination) 31/07/05 \$8.00 (extended to 31/8/05)
YEARLING NOMINATIONS (2nd Nominations) 31/07/06 \$ 10.00
TWO YEAR OLD NOMINATIONS (3rd Nomination) 31/07/07 \$ 12.00

TOTAL ENTRY FEE OF \$30 can be split into the 3 sections & payment received by nominated dates each year or paid in a lump sum with first nomination

12. Non-payment of fees will mean automatic cancellation.
13. Entries can be on photocopied copies of entry form, but please ensure all relevant details are included.
14. The first Tasmanian foal futurity will provide classes for:
Buckskins colts Buckskin fillies Buckskin geldings
Foundation / appendix colts Foundation / appendix fillies Foundation/Appendix geldings
15. Classes will be combined if insufficient final entries.
16. NO late entries will be accepted.
17. Committees decision are final & disputes will be entered into.
